THE SASINE REGISTER

Whenever a disposition affecting the land in a title occurs, such as a sale or mortgage, a Title Register is created, or the existing one is updated. Entries relating to previous ownerships and charges are removed and the new ownership and charge details are recorded.

Prior to first registration the title records were retained as handwritten or typed records sheets in the National Archives of Scotland. In 1876 the Registrars of Scotland began keeping property search sheets, identified by volume and page numbers indexed to the sasines and deeds, and are now retained as scanned images in the Sasine Register. This is a register that

records the transfer of ownership of real property, i.e. a house or parcel of land.

Our Sasine Register search relates only to the register retained by the Registrars of Scotland.
